(Smoke and Mirrors, cont.) provide anyone with legal representation who is in need of it. This has been an expensive but necessary decision. This legal process has been going on for nine months. The forty four defendants are not just fighting this action for their own benefit, but for the preservation of community rights to lands along the river, which is a historical fixture in this village and belongs to every resident—not just one or two individuals. The Quiet Title suit plaintiffs (Gafford and Clayton) have no legal representation and no costs to date.

We believe these actions fall under the heading of "harassment" and wish to encourage the community at large to send contributions to the Legal Defense Fund, making checks out to the GCA and noting the fund in the memo space. The defendants have carried the burden of extensive legal fees to date along with the additional support of a few community-minded angels. We now need more help. Please give what you can. We will soon be making our case before the courts.

## **WATER BOARD MEETS**

The Board of Directors of the Galisteo Water Users Association met on April 12<sup>th</sup> at the Fire Station. One of the principle discussions was about the \$150,000 appropriated by the State Legislature for Galisteo water system improvements. This money, which is being channeled through the NM Environment Department, will be available in May or June. It will be used for such things as improving the storage tank, replacing one of the water lines, and eventually, installing meters at member households. The Association's own funds will cover the new well about to be drilled.

The annual membership meeting was held on Wednesday May 3. All those whose terms were expiring were re-elected: Vice President Scott Diffrient, Secretary Ted Fleming, Treasurer Richard Griscom, Board Members Freddie Cárdenas and Steve Moya, Rod Hall remains President.

## **GCA REPORT**

The Galisteo Community Association met April 17<sup>th</sup>. Frank Hirsch and Sam Medford came to the Open Forum to inform the Board about a group of concerned village residents who have been meeting to monitor the County's and State's plans for road improvements on CR 42 and NM 41, in order to make sure that the improvements are consistent with the "rural aspect of our historic village." In order to maintain awareness of the plans and to affect their design and outcome, the Board established an "official" Galisteo Road Committee.

Former **Treasurer** Frank Hirsch, handing over his responsibilities to Corinne Anaya, **reported** that the GCA has c. \$13,250 in the bank: \$10,000 in CDs; \$1,100 in a fund in memory of Linda McKee; \$732 in the Legal Defense Fund (administered by Richard Griscom). The balance is in the General Fund from which the operation and maintenance of GCA facilities are paid. (*Dear El Puente, cont.*) of life. Not that this is not a valid cause. It

very much is and we will help defend our wonderful community from these encroachers, but the outrage remains. Who are these people? Are they neighbors? Is this the way neighbors behave? After all this is put to rest, will we pass on the road and exchange pleasantries? We have lived in Galisteo for 32 years. I (Barbara) would not know these people if I fell on them. Do they serve on any of our volunteer organizations? Do they give to causes that benefit the entire village? If we dialed 911, would they come to our aid?

The purpose of this letter is to let our community know that we are very fed up with these two thieves who are stealing our money, time, and possibly our community lands. We are grateful to those who are spending their precious time and money to pursue this fight. To paraphrase the old movie *Network*, "We're mad as hell and we're not going to take it any more."

We implore Morgan Gafford and Peirce Clayton to behave like good neighbors, rethink their positions, and withdraw their claims. This is all a huge waste of everyone's time, energy, resources and money. Please stop this foolishness and leave our bosque alone.

(GCA cont.) The Board discussed prevention and removal of what seems to be an **increase in graffiti** in the village – on the old bridge, the central telephone boxes on NM 41, and elsewhere. The source of the problem is believed to be outside the village. With the police and sheriff's departments' limited resources, the Board asks everyone in the village to be aware of suspicious activity and report it to the authorities and to the GCA Board. It was also suggested that local youths could be involved in cleanup as a way to educate and inform them, beginning perhaps on May 20th.

On April 12<sup>th</sup> a small group of Board members reviewed the **GCA Archives** at the Community Center. They reported that not much of substance was found. Documentation of the village cemeteries was reviewed and the idea arose of a living historical archive -- recording the remembrances of village elders. At the next meeting it will be discussed as "Cemetery Tour" and a subcommittee may be formed.

GCA President Freddie Cárdenas met with County Commissioner Mike Anaya regarding funds for Community Center maintenance. The Board is also seeking to clarify the relationship between the GCA, its facilities, and the County. Highlights included: \*Sources of funds for community buildings and playgrounds and possibility of County assistance for Community Center repairs.\* The County leases the Community Center for a polling location, but has no interest in owning or controlling community facilities.\* Precedent for County financial involvement in original playground construction. The Board is considering a public meeting on County participation in GCA facilities maintenance.

## **KNOCK KNOCK! WHO'S THERE?**

Five species of Woodpeckers, that's who. The Northern Flicker, Hairy, Downy, Ladder-backed and Lewis's Woodpeckers are all here in Galisteo. The first four can be seen year-round in the Basin. All five are relatively easy to identify.

Woodpeckers in general have stiff tail feathers, strong claws and sharp padded bills that enable them to hammer out nest holes, peel away bark in search of insects, and drum out their own unique signals to mates and enemies alike. They can be lured to your feeders with suet.

The largest of our Woodpeckers is the Northern (Redshafted) Flicker. This handsome brown bird is easily identified by his white butt patch, loud call, and the undulating flight pattern typical of most Woodpeckers. That's a Flicker you hear drumming loudly on the wooden facer boards under the roof of your house. The much smaller Downy, Hairy, and Ladderbacked are primarily black and white The Hairy and Downy are most easily identified by their white backs. These two are nearly identical, but the Hairy is almost 3" larger and has a much longer bill. The Ladder-backed fits in between these two in size but has no white back patch.

The most unique of our Woodpeckers is the Lewis's. He's bigger than the three little black and white cuties, but not as large as the Flicker. The black back, greenish head, red face and pink belly tell you right off that he is something special. He flies with the slow steady wing beats of a crow and catches insects in the air like a flycatcher. I have seen this Woodpecker twice in Ranchitos, both times around Thanksgiving. For its size, Galisteo attracts more than its share of New Mexico Woodpeckers. Who knows, maybe one day we'll get an Ivory-billed!

## **MEETINGS OVERVIEW**

On March 22 a well-attended public meeting was held by the **State Parks** Department at the Galisteo Community Center to present proposals and gather input about State Parks in the Galisteo Basin. It followed a similar gathering in the San Marcos/Cerrillos area. State Parks Recreation Division Director Dave Simon presented five proposals: 1) The State taking over the existing County park at *Cerrillos Hills*. 2) The Cerrillos Hills Park plus a new one at County-owned *Petroglyph Hill* (site of a very large array of rock art on the south side of CR 42) 3) Both of the above plus another park at *Pueblo Blanco*, south of Galisteo, on State Trust Land. 4-5) No parks at all, or combinations of the above. One or more (Petroglyph Hill seemed the preference) might include a campground.

The notion of handing the Cerrillos Hills Park over to the State has been around for at least couple of years, and is mostly approved by Cerrillos residents. But the other two sites were a surprise, given their fragile archaeological resources.

County planner Beth Mills noted that the environmental impact of eco and cultural tourism has not yet been determined and that it would be premature to plan parks at Petroglyph Hill and Pueblo Blanco at this time. Most of those attending the Galisteo meeting agreed with her, although the very valid issue of elitism and NIMBY(Not in My Back Yard) was raised by those who felt we should share our publicly owned resources.

On May 1<sup>st</sup> a potluck information meeting on the **paving of CR 42** (Camino de los Abuelos) was held at the Turquoise Trail Fire Station, Gino De Angelis and John Jacquez from the County DOT presiding. Three people from Galisteo and seven from San Marcos attended. The plans now call for *two 10' lanes and two 4' bike lanes*, with minor straightening, and a cement pad but no bridge at Arroyo de Los Angeles. The few alterations will not change the right of way and general path of the road. No new land will be acquired. Construction will begin in late 2006.

On May 5 the **Galisteo Watershed Partnership** met at the Community College for a "Conservation Initiatives Dialogue." Representatives from Earth Works Institute, County Planning and Open Space, Taos BLM, State Parks, State Forestry, National Parks, Santa Fe Conservation Trust, Commonweal Conservancy, Eldorado Improvement Association, and the Galisteo Planning Committee were present. A great many facets of the Galisteo Watershed's health were discussed in this productive gathering. (Cont. p.4)

Of particular interest to Galisteo: \* The BLM's work on the Archaeological Protection Act; possible designation of the Galisteo Basin as a "special area" for environmental and cultural resources. Visual resources (the views), oil/gas and gravel pits, and transportation access also to be considered. \* The Forestry Dept.'s Watershed Health Plan, offering help to private landowners of over 10 acres for fuel reduction projects, clearing dead trees and replanting, as well as preparing for climate change (both the State Engineer and the Environment Dept. are doing reports). \* State Parks in the Basin (see above.) \*The San Marcos plan's strategies for maintaining low residential density and monitoring the acquifer and Santa Fe's creep south. They have no interest in a County-wide water system. \* The Army Corps of Engineers' salt cedar eradication plan upstream of the Galisteo Dam, using mechanical extraction, then goats, and finally chemicals, if all else fails.\* State acquisition of the old DNSF Railway right of way on the North Bank of the Galisteo Creek.\* EWI's Wetlands Project, mapping all the watershed's wetlands and springs and relating them to alluvial storage and water-storing soils.\* A much needed all-encompassing layered GIS mapping program for the watershed.
