### **Compensation**

With filming projects they sometimes want to use a house or location.

Agreements should be made in advance before production starts.

Those negotiations will be made by the property owner and the film production team. It is very important to take into consideration neighbors and how filming might impact them.

Night shooting, lights and traffic along with parking should be noted and shared with the Galisteo

Community Association to alert the village of any upcoming activities.

#### **Retainers**

It is common practice to require a retainer from production companies in case there is any kind of damage to roads or compensation for issues not held up in a contract. Please

### **Existing Movie Sets**

Silverado film site is just south of Galisteo. Located at the Cerro Pelon Ranch, 5547 Highway 41. The San Cristobal Ranch site is just east of Galisteo. Access through La Otra Vanda is not allowed as the road can not take heavy loads. Access should be done from Hwy 285 or up by the rodeo grounds.





### **Major Issues**

#### **Traffic and Roads**

The Galisteo bridge is not designed for large trucks or loads and has a weight limit.

La Otra Vanda is a private road, not county, and can not handle large trucks or semi traffic. Old water lines run underneath the roads for the village water source and heavy loads can damage the village infrastructure.

Traffic running into the village also creates noise disturbance for those who live near by. Also the vibration of larger trucks is damaging to the older buildings in the area and we have had complaints of adobe walls and ceilings crumbling from heavy traffic.

Also any parking in the village should have notice to let folks know they have permission. We suggest to limit the number of vehicles and shuttling film staff.

#### **Night Shooting and Lights**

Lights and noise issues have happened in the past.

Western gun shooting without warning the neighbors can be serious problem for neighbors on the East side of Galisteo. It is imperative that notice be given to the neighbors so as not to scare them or call the sheriff to report gun fire. Also, lighting can also be a problem if it reflects towards the neighbors near the set.
